Louisiana	1	1	link (Exec Order) link (law)	<i>EO JBE 2018-15</i> - Required declaration by bidders: "...“By submitting a response to this solicitation, the bidder or proposer certifies and agrees that the following information is correct: In preparing its response, the bidder or proposer has considered all proposals submitted from qualified, potential subcontractors and suppliers, and has not, in the solicitation, selection, or commercial treatment of any subcontractor or supplier, refused to transact or terminated business activities, or taken other actions intended to limit commercial relations, with a person or entity that is engaging in commercial transactions in Israel or Israeli-controlled territories... ” <i>2019 law</i> : bars procurement contracts with vendors that engage in a boycott of Israel, using same language as in EO described above.
